NOTES

1. An additional 20% pricing will be applied to all service prices for IMCO containers.
2. Cargoes classified as IMCO classes 1, 2, 6, and 7 will not be handled in CFS area. A Turkish MSDS form must be submitted to the port for containers that will undergo internal discharge.
3. For containers entering the CFS area for stuffing, stripping, full inspection, inspection, or sampling requests, a port terminal fee of 128 USD per unit will be applied in the event of daily delays or cancellations of the request.
4. Our stripping service (by Forklift) covers operations with a maximum capacity of one forklift of 5 tons.
5. A fee for "Container Sweeping" service will be charged for each container for which stripping service is provided.

*This includes re-weighing the container in stock based on the customer's request.
